The development of the Supply Chain Ethics and Anti-Corruption Programme (SCEAP) provides members of the Coalition with a training instrument to make their SME suppliers ethically aware and hence more able to run sustainable businesses

The cross-border related roundtables resulted in dialogue and stronger relationships among public and private sector stakeholders from both Mozambique and South Africa, with a shared commitment to improving identified corruption issues
